

# BOARD OF DIRECTOR/MEMBER MEETING MINUTES Monday, March 13, 2022

1.Introduction by Rick- 6:00 pm called meeting to order.

3. Board Member reports

a- **Treasurer report**- (Tish) - Profit and Loss statement for February 2023. Total income including dues, advertising, late fees \$41887.83. Expenses totaled \$6465.37 including payroll and rent. Net income \$35,422.46.

- b- **Secretary** (Tish) read minutes from February 2023. Leroy made a motion to accept the minutes and a member 2nd, voted, passed.
- c- **Violations** Leroy- 119 violations for the month of February. 10 automobiles, 24 trailers, early debris taken out. Last month 111. expecting less this month.

- e- Liaison- Tim- Developer update: Bill Klohn is actively involved in garage development. Florida home builders are slow moving, SLID may make an attempt to purchase property back. Eco living apartments moving well. Eco Village is still waiting for studying. GIP property still waiting, Signature H site plans have been submitted. Village X, RV park and motor home approved. Valley Barisma purchased 10 acres just NE corner of Floral, interested in having a strip mall with things the community might like.
